STATUS OF DIRECTIVES AND GUIDANCE PRODUCTS ISSUED BY THE FINANCIAL INTELLIGENCE CENTRE BEFORE 2 OCTOBER 2017

1. The Minister of Finance determined the commencement dates of certain sections of the Financial Intelligence Centre Amendment Act, 2017 (Act 1 of 2017) (FIC Amendment Act) on 13 June 2017. A full schedule of the commencement dates of the various sections of the FIC Amendment Act can be accessed [here](#).
2. The amended Money Laundering and Terrorist Financing Control Regulations (the MLTFC Regulations) and the withdrawal of the Exemptions made in terms of the Financial Intelligence Centre Act, 2001 (Act 38 of 2001) (FIC Act), took effect on 2 October 2017.

Status of directives

3. All directives issued by the Financial Intelligence Centre (the Centre) remain in effect.

Status of guidance products

4. The schedule below indicates the status of all guidance products (Guidance Notes and Public Compliance Communications) issued in terms of section 4(c) of the FIC Act (Schedule of Status of Issued Guidance Products), in the following categories:
 - 4.1 Guidance products that are unaffected by the commencement of the amendments to the FIC Act and the MLTFC Regulations and the withdrawal of the Exemptions and therefore continue to apply;
 - 4.2 Guidance products that will be amended and reissued in due course and continue to apply in their current form until they are reissued.

- 4.3 Guidance products that apply up until 1 October 2017 are withdrawn by this Notice with effect from 2 October 2017.
5. All guidance products issued prior to 2 October 2017 should continue to be referenced for purposes of compliance, supervision and enforcement of the requirements of the FIC Act for the period prior to 2 October 2017.
